

# G/On™ Version 5 License Agreement

## END-USER LICENSE AGREEMENT FOR GIRITECH A/S SOFTWARE

### **IMPORTANT-READ CAREFULLY**

This non-exclusive End-User License Agreement ("EULA") is a legally binding agreement between You (either an individual or a single entity) and Giritech A/S for the Giritech A/S software product, G/On Version 5 which includes the G/On™ server software and the G/On™ software clients and may include associated media, printed materials, and "online" or electronic documentation ("SOFTWARE PRODUCT"). By using the SOFTWARE PRODUCT, You (corporation or legal entity) agree to be bound by the terms of this EULA. If You do not agree to the terms of this EULA, You are not authorized to install and/or use the SOFTWARE PRODUCT.

### SOFTWARE PRODUCT LICENSE

#### **1. Grant of License**

Upon proper payment this EULA grants You the following rights:

##### *Installation and Use.*

You may use this SOFTWARE PRODUCT on the number of servers, for the number of users, for the number of authentication tokens and with the functionality accepted by Giritech A/S as described in the license details received from Giritech during installation of the SOFTWARE PRODUCT. You may not make copies of the SOFTWARE PRODUCT, add users beyond what is described in the license details or use functionality for which You have not been granted license rights unless this is necessary for the intended purpose of this license and in accordance with this EULA. Giritech A/S reserves all rights not expressly granted to You.

- i. This EULA sets the maximum number of known users that can access the G/On Server as the Number of Users (User Access Licenses) as defined in your G/On License.
- ii. This EULA sets the maximum number of known Authentication Tokens that can be enrolled into the G/On Server as the Number of Tokens (Token Access Licenses) as defined in your G/On License.
- iii. The Server Feature "Additional Gateway Servers" entitles you to run a number (as purchased) of additional instances of G/On Gateway Servers as long as each server instance manages one and the same set of users and enrolled authentication tokens and managed by one and the same G/On Management Server.
- iv. This EULA sets the following specific licensing terms for G/On Help:
  - a. The maximum number of users that can use G/On Help Client is given by the number of G/On Help Client purchased and defined in your G/On License. The maximum number of users that can use G/On Help Client Advanced is given by the number of G/On Help Client Advanced purchased and defined in your G/On License. The maximum number of users that can use G/On Help Client (non-G/On) is given by the number of G/On Help Client (non-G/On) purchased and defined in your G/On License.
  - b. The G/On Server Feature "G/On Help Manager" entitles you to install the G/On Help Manager software to be used by G/On Help managers (Technical Support Consultants).

##### *License.*

The SOFTWARE PRODUCT is only licensed to You. You may not transfer your rights under this EULA. The SOFTWARE PRODUCT may not be sold, sublicensed, leased or lent unless explicitly agreed in writing by Giritech A/S or appointed representative.

##### *ASP Partner*

You may lease or lent the SOFTWARE PRODUCT, if You have signed a ASP Partner Agreement with Giritech, and You will then be subject to the terms and conditions set forth in the ASP Partner Agreement.

#### **2. Description of Other Rights and Limitations**

##### *Limitations on Reverse Engineering, Decompilation, and Disassembly.*

You may not reverse engineer, decompile, or disassemble the SOFTWARE PRODUCT, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.

#### *Separation of Components.*

The SOFTWARE PRODUCT is licensed as a single product. Its component parts may not be separated and may not be used by more simultaneous users than You have acquired licenses for except as specifically governed by this EULA.

#### *Upgrading*

Giritech A/S intends to develop updates to the SOFTWARE PRODUCT. If and to the extent such updated versions of the SOFTWARE PRODUCT are available, You may acquire updates of the versions of the SOFTWARE PRODUCT for which You have valid license through Giritech A/S's Maintenance Program.

Any and all updated versions of the SOFTWARE PRODUCT rightfully acquired by You through Giritech A/S' Maintenance Program are covered by this Agreement. However, Giritech A/S shall not have any responsibility or liability for the installation of the updated versions of the SOFTWARE PRODUCT. Unless rightfully acquired by You through Giritech A/S' Maintenance Program, this Agreement does not give You the rights to updated versions of SOFTWARE PRODUCTS.

#### *Duration and Termination.*

This license is valid until terminated. Without prejudice to any other rights, Giritech A/S may terminate this EULA if You fail to comply with the terms and conditions of this EULA. In such event, You must return all copies of the SOFTWARE PRODUCT and all of its component parts ten (10) business days from the formal notification by Giritech A/S that the EULA has been terminated. Further, You shall delete any copies of the SOFTWARE PRODUCT from any and all media.

### **3. Maintenance**

By buying the Giritech SOFTWARE PRODUCT You must subscribe to 1 year of mandatory maintenance. If Giritech releases any updates or new releases of the SOFTWARE PRODUCT maintenance will make You entitled to receive such updates(s) or new releases(s) for your licensed software at no additional cost, except for any connection charges, taxes, duties and shipping costs if You select fulfillment by mail. Such updates and new releases shall be considered part of the SOFTWARE PRODUCT and subject to all of the terms and conditions of this EULA unless otherwise indicated in any license agreement that accompanies such updates or new releases. Besides from the first year of mandatory maintenance, maintenance can be purchased additionally to the SOFTWARE PRODUCT and will be subject to the terms and conditions in Section 3 of this EULA. Maintenance subscription will automatically be renewed, unless cancellation has occurred minimum 60 days before the anniversary of the maintenance period. Updates and new releases of the SOFTWARE PRODUCTS may contain new and added functionality for which additional license may be required.

### **4. Copyright**

All title and copyrights in and to the SOFTWARE PRODUCT (including but not limited to any codes, images, photographs, animations, video, audio, music, text, and "applets" incorporated into the SOFTWARE PRODUCT), the accompanying printed materials, and any copies of the SOFTWARE PRODUCT are owned by Giritech A/S or its suppliers. The SOFTWARE PRODUCT is protected by copyright laws and international treaty provisions.

### **5. Giritech Limited Warranty**

Giritech A/S warrants that (i) the SOFTWARE PRODUCT in its unmodified standard version released by Giritech A/S will perform substantially in accordance with the accompanying user documentation for a period of ninety (90) days from the date of receipt; and (ii) any media will be free from defects in materials and workmanship under normal use and service for a period of ninety (90) days from the date of receipt.

Giritech A/S' entire liability and Your exclusive remedy under the foregoing warranty shall be at Giritech A/S' option: either (i) return of the part of the license fee paid by You and received by Giritech A/S for licensing the SOFTWARE PRODUCT or (ii) repair or replacement of the SOFTWARE PRODUCT that does not meet this Limited Warranty. This Limited Warranty is void if failure of the SOFTWARE PRODUCT has resulted from accident, abuse, or misapplication. Any replacement of the SOFTWARE PRODUCT will be warranted for the remainder of the original warranty period or thirty (30) days, whichever is longer. Any modification of the SOFTWARE PRODUCT by anyone other than Giritech A/S voids the foregoing warranty.

If an implied warranty or condition is created by your state/jurisdiction and federal or state/provincial law prohibits disclaimer of it, you also have an implied warranty or condition, BUT ONLY AS TO DEFECTS DISCOVERED DURING THE PERIOD OF THIS LIMITED WARRANTY (NINETY DAYS). AS TO ANY DEFECTS DISCOVERED AFTER THE NINETY-DAY PERIOD, THERE IS NO WARRANTY OR CONDITION OF ANY KIND. Some states/jurisdictions do not allow limitations on how long an implied warranty or condition lasts, so the above limitation may not apply to you.

Any supplements or updates to the SOFTWARE, including without limitation, any (if any) service packs or hot fixes provided to you after the expiration of the ninety-day Limited Warranty period are not covered by any warranty or condition, express, implied or statutory.

Except for the Limited Warranty and to the maximum extent permitted by applicable law, Manufacturer and its suppliers (including Giritech, Giritech Corporation (including its subsidiaries) and their respective suppliers) provide the SOFTWARE and support services (if any) AS IS AND WITH ALL FAULTS, and hereby disclaim all other warranties and conditions, whether express, implied or statutory, including, but not limited to, any (if any) implied warranties, duties or conditions of merchantability, of fitness for a particular purpose, of reliability or availability, of accuracy or completeness of responses, of results, of workmanlike effort, of lack of viruses, and of lack of negligence, all with regard to the SOFTWARE, and the provision of or failure to provide support or other services, information, software, and related content through the SOFTWARE or otherwise arising out of the use of the SOFTWARE. ALSO, THERE IS NO WARRANTY OR CONDITION OF TITLE, QUIET ENJOYMENT, QUIET POSSESSION, CORRESPONDENCE TO DESCRIPTION OR NON-INFRINGEMENT WITH REGARD TO THE SOFTWARE.

## **7. Limitation of Liability**

You have the sole responsibility and liability for the selection, installation and use of the SOFTWARE PRODUCT, as well as the results and outcome of the use of the SOFTWARE PRODUCT. Giritech A/S shall have no responsibility and liability for any upgrading, servicing and supporting with respect to the SOFTWARE PRODUCT, including such provided by third parties and partners of Giritech A/S.

Giritech A/S shall not be liable for any incidental, special, punitive, exemplary or consequential damages arising from or connected with this Agreement or Your use of the SOFTWARE PRODUCT (including, without limitation, damages for loss of business profits, business interruption, loss of business data and information or other pecuniary loss) and arising out of the use of or inability to use this SOFTWARE PRODUCT, even if Giritech A/S has been advised of the possibility of such damages.

Notwithstanding any damages that you might incur for any reason whatsoever (including, without limitation, all damages referenced herein and all direct or general damages in contract or anything else), the entire liability of manufacturer and any of its suppliers (including Giritech, Giritech Corporation (including its subsidiaries) and their respective suppliers) under any provision of this EULA and your exclusive remedy hereunder (except for any remedy of repair or replacement elected by manufacturer with respect to any breach of this limited warranty) shall be limited to the amount actually paid by you for the software.

If an implied liability is created by your state/jurisdiction and federal or state/provincial law prohibits disclaimer of it, you also have an implied liability, BUT ONLY AS TO DEFECTS DISCOVERED DURING THE PERIOD OF THIS LIMITED WARRANTY (NINETY DAYS). AS TO ANY DEFECTS DISCOVERED AFTER THE NINETY-DAY PERIOD, THERE IS NO WARRANTY OR CONDITION OF ANY KIND. Some states/jurisdictions do not allow limitations on how long an implied warranty or condition lasts, so the above limitation may not apply to you.

Any supplements or updates to the SOFTWARE, including without limitation, any (if any) service packs or hot fixes provided to you after the expiration of the ninety-day Limited Warranty period are not covered by any warranty or condition, express, implied or statutory.

The foregoing limitations, exclusions and disclaimers (including sections 4, 5, and 6) shall apply to the maximum extent permitted by applicable law, even if any remedy fails its essential purpose.

The SOFTWARE PRODUCT and documentation are provided with RESTRICTED RIGHTS. Use, duplication, or disclosure by the Government is subject to restrictions as set forth in subparagraph (c)(1)(ii) of the Rights in Technical Data and Computer Software clause at DFARS 252.227-7013 or subparagraphs (c)(1) and (2) of the Commercial Computer Software-Restricted Rights at 48 CFR 52.227-19, as applicable.
